

Online Learning Revealing the Benefits and Challenges

The article I chose to review explores whether high school students could benefit from online courses and examines the potential challenges and drawbacks of online coursework. It goes on to review questions on how to best support high school students enrolled in an online course. The first section on the paper defines what online learning is and why it has such an appealing range to learners.

In the literature review, the author points out how critical the understanding of online learning is, and that there is not a single description that would encompass all assets of online learning environments. The Department of Education conducted the “Distance Education Courses for Public Elementary and Secondary School Students” survey in 2002-03 school year to gain insight into the prevalence of distance learning in public school districts. The findings revealed that approximately one-third or 5,500 out of a total of 15,040 public school districts had at least one student enrolled in a distance learning course during the 2002-03 school year (Setzer & Lewis, 2005). In 2009-10, the number of public school districts offering distance education courses rose to an estimated 53 percent (Institute of Educational Sciences, 2014).

The article stated that distance learning is far more widely used in postsecondary educational settings, and there were statistics to prove that this is true. Online learning seems to appeal to diverse populations of students with ranging academic needs that traditional education classes are incapable of meeting. It has much more flexible learning environments for learners who might have phobias linked to the more concrete environment of the traditional school setting.

The next paragraph explores the various advantages of the online learning format. The benefit of flexibility in online courses cannot be overstated. Online learning allows for students to

work at a time and a place that is compatible with their learning needs. Another major benefit the article stated was the accessibility it allows students. One student went on to state, "I can take classes that my school doesn't offer, and I can work when I have free time or a lighter homework load in my school classes" (Thomson, 2010). It also went on to state the importance of feedback, which is an area that both instructors and students stressed as being vital to success in an online course.

The following article covered the drawbacks and potential issues that students may face while participating in an online course. One factor that is frequently examined is the development of community and peer interaction in a traditional classroom setting compared to an online learning environment. Literature suggests that a strong and active social life on campus can be important to learning satisfaction.

Analyzing these various variables may offer more insight as to the type of content that is more suitable for an online environment. Also, the study does not take into account the different types of

instructional methods of the online instructor. If you were to broaden the population, this would allow for more insight on student ability. I think this applies to me and my classroom because it gives me concrete evidence to why and how online courses offer such an excellent way for students to broaden their educational opportunities. It allows students to stay competitive in the ever evolving world of education. Especially for high school students who are about to enter the world of college. In college, some of the classes they need to take so they can graduate might only be offered online.
